Whereas:

1. In the United States, the Nuremberg Kodex and the related Declaration of Helsinki form the basis for the Code of Federal Regulations - Title 45 Part 46 - which are the regulations issued by the United States Department of Health and Human Services for the ethical treatment of human subjects, and are used in Institutional Review Boards (IRBs);

2. The Nuremberg Kodex states:

- 1. The voluntary consent of the human subject is absolutely essential.
- 2. The experiment should be such as to yield fruitful results for the good of society, <u>unprocurable</u> by other methods or means of study, and not random and unnecessary in nature.
- 3. The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease or other_problem under study that the anticipated results will justify the performance of the experiment.
- 4. The experiment should be so conducted as <u>to avoid all unnecessary physical and mental suffering and injury</u>.
- 3. In 1966, the International Covenant on Civil and Political Rights was adopted by the United Nations, and put in force by the United States on 8 September 1992; in which, Article seven prohibits experiments conducted without the "free consent to medical or scientific experimentation" of the subject;
- 4. The National Vaccine Information Center represents citizens from every state, who support the principle of informed consent to medical treatment, which has become a central ethical principle in the practice of modern medicine and is applied to medical interventions which involve the risk of injury or death; and, implicit in the concept of informed consent is the right to refuse consent or, in the case of vaccination laws, the right to exercise conscientious, personal belief or philosophical exemption to mandatory use of one or more vaccines;
- 5. Title 21 of the Code of Federal Regulations (CFR) states that Americans in a clinical study must give their written consent to any medical treatment such as vaccination; and, informed consent requires candidates for vaccination to be given the right to refuse vaccination; have the right to confidentiality (privacy) that their vaccination data will not be shared with other parties without their consent; and have the right to know if there are any alternatives to vaccination;
- 6. A NIH study concludes: "That vaccines designed empirically using the traditional approach (consisting of the unmodified or minimally modified coronavirus viral spike to elicit neutralizing anybodies), be they composed of protein, viral vector, DNA or RNA and irrespective of delivery method, may worsen COVID-19 disease via antibody-dependent enhancement (ADE). This risk is sufficiently obscured in clinical trial protocols and consent forms for ongoing COVID-19 vaccine trials that adequate patient comprehension of this risk is unlikely to occur, obviating truly informed consent by subjects in these trials";
- 7. Coercion is being used to create compliance to an injection of an experimental mRNA gene therapeutic;
- 8. Alternative effective therapeutics have been known by the NIH, WHO and CDC, but have been prohibited for use by the public in order to allow EUA vaccines into the market;
- 9. The mRNA gene therapeutic injections neither prevent infection nor stop contamination and are, therefore, not vaccines, technically;

- 10. The number of deaths by mRNA gene therapeutic injections in 2021 have surpassed the combined death count by all vaccines since 1990, as reported to the Vaccine Adverse Events Reporting System (VAERS);
- 11. The treatments being marketed as COVID-19 vaccines are still in Phase III clinical trials until 2022 to 2023, for Moderna and Pfizer, respectively, and hence qualify as medical experiments. People being subjected to these treatments are not told they are the guinea pigs enrolled in clinical trials:
- 12. None of these treatments have been approved, but only granted emergency use authorization, and even if they were approved informed consent would still be required;
- 13. Most vaccines are trialed for at least 5-10 years, and COVID-19 vaccines have not even been tested in animal studies. All previous animal studies killed the animals once their immune system was challenged by other viruses;
- 14. No other coronavirus vaccine (ie. MERS, SARS-1) has been approved for market, due to antibody dependent enhancement (ADE) resulting in severe illness and deaths in animal models;
- 15. Numerous doctors, scientists and medical experts are issuing dire warnings about the short and long-term effects of COVID-19 vaccines; an October 2020 symposium sponsored by the FDA, detailed the following adverse events:
 - Guillain-Barré syndrome
 - Acute disseminated encephalomyelitis
 - Transverse myelitis

- 16. The overall survival rate for COVID-19 is 99.9%, the equivalent of the common cold;
- 17. Only 1% -10% of vaccine injuries are reported to VAERS according to a Harvard study. According to a CDC document, only 0.014% are reported. The full extent of adverse events from the COVID vaccines is unknown as there is at least a three month delay in uploading reports to the VAERS database;
- 18. Breakthrough cases and deaths of COVID-19 infections in those who have received COVID-19 vaccines are on the rise; as at September 7:
- a. 14,506 deaths followed a Covid vaccination.
- b. 88, 171 serious injuries followed a Covid vaccination.
- 19. The trials have not proven that COVID-19 vaccines prevent infection or transmission, and the vaccinated are the generators of the Delta variant according to Nobel Prize winner, Luc Montagner;
- 20. The CDC, on March 24, 2020, published the directive which instructed medical practitioners to ascribe all deaths to COVID-19, on the mere assumption a patient was infected, without any testing or autopsy. In the case of a pandemic, this tactic was clearly meant to generate the fear that led to the lockdowns. And the remedy to the lockdowns was the vaccines;
- 21. Variants of a virus are invariably attenuated versions of the original virus but more transmissible. This is a known medical fact:
- 22. According to the CDC these injections only lessen the severity of the illness and don't prevent infection or contamination, and are by definition, therefore, not vaccines;
- 23. Murder is defined as:
 - intentionally inflicting serious bodily harm that causes the victim's death, or
 - behaving in a way that shows extreme, reckless disregard for life and results in the victim's death.

Now therefore, any coercion or pressure tactics used on employees to be vaccinated contravenes the Nuremberg Code, as well as the Helsinki Declaration, and the US Crimes Against Humanity Act of 2010 that amended the Federal Criminal Code to impose a fine and/or prison term of up to 20 years (or any term of years or for life if death results from a violation of the prohibitions of this Act) on any person who commits or engages in conduct that would violate specified federal criminal laws (including murder, kidnapping, peonage, involuntary servitude, forced labor or tracking in persons, sex tracking of children, sexual abuse, hostage taking, torture, extermination, national, ethnic, racial, or religious cleansing, or measures intended to prevent births) as part of a widespread (not less than 50 victims) and systematic attack against any civilian population, with knowledge of the attack, and your tactics are tantamount to conspiring and engaging in extermination and national cleansing.

This Notice of Liability is to hereby notify your corporate staff, board members and executives, and any medical personnel, this includes public health nurses or health officials:

They will be held personally and criminally liable for any injuries or deaths that may occur from coercing employees to be injected with an experimental medical intervention at pain of losing their job.

In addition, irrespective if any harm should come from forced vaccinations on the employee, for you merely intending and conspiring to inject employees with experimental substances without any regard for their safety or their informed consent, you are hereby named as a codefendant in Crimes Against Humanity to be adjudicated in international tribunals, should such trials be convened.
