## THIS IS YOUR OFFICIAL NOTICE OF LIABILITY FOR CRIMES AGAINST HUMANITY

## YOU HAVE BEEN SERVED FOR NOT ADHERING TO THE NUREMBERG CODE

You will be named as an accomplice to crimes against humanity for:

- promoting a manufactured pandemic
- promoting experimental injections without providing full and transparent informed consent
- depriving people of their innate right to choose what goes into their body without fear of reprisals or repercussions
- prohibiting the truth from surfacing, and for
- essentially contravening the Nuremberg Code, which supersedes national Constitutions

The penalty for crimes against humanity is death or imprisonment. You will be summoned to a tribunal, as and when tribunals will be convened virtually or in a court room, and you could also be tried in absentia.

This excerpt was published in the New England Journal of Medicine in 1997. It is a speech given by Dr. Evelyn Shuster to commemorate the 50th anniversary of the Nuremberg Code.

"1. The voluntary consent of the human subject is absolutely essential.

This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment.

The duty and responsibility for ascertaining the quality of the consent rests upon each individual who initiates, directs or engages in the experiment. It is a personal duty and responsibility which may not be

delegated to another with impunity.

2. The experiment should be such as to yield fruitful results for the good of society, unprocurable by other methods or means of study, and not random and unnecessary in nature.

3. The experiment should be so designed and based on the results of animal experimentation and a knowledge of the natural history of the disease or other problem under study that the anticipated results will justify the performance of the experiment.

4. The experiment should be so conducted as to avoid all unnecessary physical and mental suffering and injury.

5. No experiment should be conducted where there is an a priori reason to believe that death or disabling injury will occur; except, perhaps, in those experiments where the experimental physicians also serve as subjects.

6. The degree of risk to be taken should never exceed that determined by the humanitarian importance of the problem to be solved by the experiment.

7. Proper preparations should be made and adequate facilities provided to protect the experimental subject against even remote possibilities of injury, disability, or death.

8. The experiment should be conducted only by scientifically qualified persons. The highest degree of skill and care should be required through all stages of the experiment of those who conduct or engage in the experiment.

9. During the course of the experiment the human subject should be at liberty to bring the experiment to an end if he has reached the physical or mental state where continuation of the experiment seems to him to be impossible.

10. During the course of the experiment the scientist in charge must be prepared to terminate the experiment at any stage, if he has probable cause to believe, in the exercise of the good faith, superior skill, and careful judgment required of him, that a continuation of the experiment is likely to result in injury, disability, or death to the experimental subject.

The Nuremberg Code is the most important document in the history of the ethics of medical research. The Code was formulated in August 1947, in Nuremberg, Germany."

- 22. asymptomatic spread of a disease is false science
- 23. the survival rate for Covid is 99.9%, similar to the survival rate for influenza, and influenza can produce even more severe symptoms than Covid
- 24. annual flu statistics have been replaced by Covid data, and 96% of Covid deaths had preexisting conditions

- 25. the weekly number of deaths from 2019 going into 2020 remained constant
- 26. the SARS-CoV-2 virus has yet to be isolated after more than 120 Freedom of Information requests
- 27. the unscientific misclassification of active cases
- 28. double-standard mask mandates for the elite and their peons
- 29. quarantining asymptomatic people
- 30. nasal swabs contaminated with Ethelyn Oxide
- 31. Bill Gates predicted the world population could decrease by 10%-15% with the right vaccines
- 32. Covid-19 is part of the Great Reset, according to the World Economic Forum
